### Terms of Contract

The stud fee of \$2500 USD shall be paid in full before AKC and/or ASCA litter registration papers are signed by stud dog owners. A deposit of half the total stud fee, \$1250.00, is due at the time of breeding, and is deducted from the total fee.

A litter shall constitute 2 live, regularly marked puppies (not mismarked as per Breed Standard) at 1 week of age. One (1) return service at no charge is available to the same bitch, or another agreed upon bitch, to the same stud dog or to another stud dog owned by Stud dog owner, as applicable, if 2 regularly marked puppies at 1 week of age do not result from this breeding providing the above conditions are met, within 12 months time. To receive the return service, the bitch owner must notify the stud dog owner of failure to conceive, in writing, not more than 3 weeks after the expected date of whelping. Failure to do so will result in denial of return service. Bitch owner will be responsible for any expenses incurred by the Stud Dog owners during said return service, such as veterinarian fees. Under no circumstances will the stud fee deposit be reimbursed if the return service is unsuccessful within 12 months or if the Bitch owner elects not to claim a return service or for any other reason.

Any and all shipping charges are the responsibility of the owner of the bitch to be bred and must be prepaid. Any and all expenses associated with reproductive services (including but not limited to: collection, kits, shipping/artificial insemination/progesterone testing) must be paid in full by the owner of the bitch to be bred and must be paid before the Stud Owner signs litter registrations. Any and all other expenses, such as boarding costs, veterinarian costs, etc., must be paid before the Stud Owners sign litter registrations.

The Stud Dog Owners or Agent will not be held responsible for disease, accident, loss,

injury, or death to the Bitch or to any other person or animal while on the premises or in transit.

### Owners of Stud agree to the following:

- Provide the bitch owner with complete pedigree and health clearance information.
- Care for the bitch responsibly while in our charge, and keep the bitch confined and ensure that she is not mated to other dogs.
- Sign litter registrations promptly and return them to the Bitch owner upon fulfillment of said agreement.
- Provide a return stud service as stated in Terms of Contract above.
- Notify the owners of date(s) of live cover breeding and provide photographic evidence of a tie. In the event that a live cover is not possible, the stud dog owners will request permission to have an A.I. performed by a licensed Veterinarian.

### Owners of Bitch agree to the following:

- Pay the agreed stud service deposit of \$1250 USD as stated in Terms of Contract above prior to the Bitch being serviced, and pay the remaining stud service fee of \$1250 USD upon arrival of litter, prior to AKC and/or ASCA litter registration papers being signed by stud dog owners.
- Pay any expenses incurred while the bitch is in the care of the stud owners, including but not limited to veterinarian fees.
- Send the Bitch in good health and in season. Ideally perform progesterone testing on the bitch to determine optimal breeding timing.
- Keep the Bitch confined before and following the breeding to ensure that no other dog can accidentally mate her before she is serviced by the Stud or prior to the end of her estrus.
- Prior to breeding, provide the Stud owners with a current clear Brucellosis test certificate, OFA certificate, current eye exam certificate (within 1 calendar year of the date of breeding), a 4-generation pedigree, and registration certificates.
- Dock tails of all puppies and remove any rear dew claws from this litter.
- Provide a litter record sheet to the Stud owners (to notify of sex, colour, tail length, etc.)
- Perform an OFA Eye exam at 6-8 weeks old on each and every puppy and inform Stud Owners of the results.
- Notify the Stud Dog owners of any titles achieved by puppies from this breeding and to notify the Stud Dog owners of any health issues in offspring resulting from this cross.
